

## Property Assessment and Inspection Procedures

This Lease Addendum ("Addendum") is hereby incorporated into the existing lease agreement ("Lease") between \_\_\_\_\_ ("Landlord") and \_\_\_\_\_ ("Tenant") for the property located at \_\_\_\_\_. This Addendum outlines the mandatory procedures and terms related to property assessments and inspections during the tenancy term.

- During the assessment, photographs of the property's condition will be taken for documentation purposes.

### 4. Privacy and Personal Items:

- RE Solutions XV respects the Resident's privacy and will not intentionally photograph personal items, belongings, or private areas.
- If personal items inadvertently appear in assessment photographs due to their location in the vicinity of areas requiring assessment, the Resident acknowledges that this is unintentional, and RE Solutions XV & representatives shall handle such situations with discretion.

Acknowledgement and Agreement:** Tenant acknowledges that the property assessments and inspections outlined in this Addendum are mandatory requirements of leasing the property from the Landlord and managed by RE Solutions XV. If Tenant does not agree with these terms, Tenant should refrain from renting the property.
